

# Labor Day Sweepstakes

Entry forms will be made available beginning 08/09/2017 at 12:00 PM Pacific time, and all entry forms must be received by 09/04/2017 at 5:00 P.M., Pacific Time at any Cardenas retail location. Individuals who fill out an entry form for the Contest and submit it in accordance with these Official Rules will have the chance to be selected to win a "Prize," with 3 prizes per store: 1<sup>st</sup> place wins a 32" TV (approximate retail value \$129.99 US Dollars), 2<sup>nd</sup> place wins a Grill (approximate retail value \$119.99 US Dollars), and 3<sup>rd</sup> place wins a \$100 Cardenas gift card (approximate retail value \$100 US Dollars).
